

CAST/FAMILY REQUIREMENTS/APPLICATION TERMS AND CONDITIONS

These Terms and Conditions (**T&Cs**) apply to all applicants for the Program currently in development, that we, Wall to Wall Media Limited (**we/us**) intend but do not undertake to produce.

- a) **Eligibility Requirements.** To be considered to take part in the Program you agree and understand that you, and any family members on whose behalf you are applying (**Family / Family Member(s)**) **MUST** meet the following eligibility requirements to the extent that they are intended to apply to you/the Family Member(s):
- (i) heads of households must be aged 18 or over;
 - (ii) you and all other Family Members must have a legal right to reside in the United States of America (USA) during the Filming Period. If you hold a visa to live and work in the USA, your visa must be valid until the 1st of November 2024;
 - (iii) All family members must have proof of identity, i.e. a valid passport, passport card, or NEXUS card;
 - (iv) You have permission from all Family Members to submit an application to participate in the Program on their behalf and to disclose their personal information for that purpose (including special category personal information and/or Personally Identifiable Information (PII));
 - (v) You have the legal authority as a guardian to give permission to all child Family Members mentioned in the application to take part in the Program without consent from any other party;
 - (vi) Any child Family Members must be at least 8 years old at the time of submitting your application;
 - (vii) You and the Family Members must be available for filming on location during the filming period which is currently anticipated to be for nine (9) weeks in July/September 2024 (to be confirmed) (Filming Period);
 - (viii) you and the Family Members are able to understand and communicate in English; and
 - (ix) you and the Family Members agree to carry out virtual recorded family interviews and collect User Generated Content (UGC) for the casting team to produce a short tape of your Family to show to the Network;

We reserve the right to change these Eligibility Requirements at any time.

- b) By applying to take part in the Program, you confirm and agree that you and your Family Members meet all of the applicable Eligibility Requirements and consent to us verifying such information as further described in paragraph (d) below.
- c) If your Family's circumstances change and you or any Family Member can no longer meet any of the Eligibility Requirements, you agree to notify us promptly by email at HistoryCasting@walltowall.co.uk
- d) Your application to the Program will still be subject to all necessary paperwork being promptly completed and returned to us by you, and our ability to undertake background checks and obtain references and other necessary information regarding your application and possible participation.
- e) You confirm that neither you nor any member of your immediate family or household (including but not limited to the Family Members) are currently or have been in the past twelve (12) months, an employee, contractor, officer, director, or agent of (i) Wall to Wall Media Limited or any other Warner Bros. Discovery company; or (ii) anyone connected with the Program. You agree to notify us in the event that this confirmation becomes untrue.
- f) You accept that your application is for an opportunity to participate only. Compliance with these T&Cs and any further correspondence with us and/or participation in casting activities (which may include a phone call or Zoom conversation with a member of the production team and/or recording an interview) does not constitute an offer to appear on or guarantee your appearance on the Program or guarantee that we will make the Program which we are developing.
